- 4.The Election Returning Officer shall publish list of election centres on notice boards of Head Officer as well as all branches within reasonable time.
5. As per section 39(1) (o) of the Multistate Cooperative Societies Act, 2002, the election program is being conducted in the General Meeting to facilitate voting of members. The atteridance of the voting members shall be considered as attendance of the meeting.
6. All the eligible members of the Society shall vote to elect **14** members of the Board of Directors.
